PUBLIC HEARING NOTICE PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 NEVADA RURAL HOUSING AUTHORITY

Notice is hereby given, in compliance with requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), Nevada Rural Housing Authority (the "Authority") proposes to issue its single family mortgage revenue bonds, in one or more series, as part of a plan of finance, bearing series designations as determined by the Authority, in an aggregate amount not to exceed \$97,000,000, for the purpose of financing mortgage loans for owner-occupied residences in the State of Nevada, excluding any area of the State of Nevada which is within the corporate limits of a city or town having a population of 150,000 or more (the "Eligible Area").

Eligible borrowers must (i) meet income limits (based on family income), (ii) meet purchase price limits for the residence, (iii) be first-time homebuyers (with certain exceptions), (iv) purchase a residence within the Eligible Area, (iv) occupy the residence as their principal residence, and (v) meet other applicable requirements.

Borrowers will be eligible to apply through lenders participating in the Authority's program.

During the public hearing, persons will have the opportunity to express their views orally.
